The prevalence of *Kushtha* is increasing day by day. There is a need to find out treatment modality which helps in Cure and *Apunarbhav* of disease. Success of treatment depends on *Trisutra of Ayurveda*.

Skin disorders have different etiological factors. Patients come to us with variety of complaints. In short, we Vaidyas, observe different *Sampraptis* and hence one may get confused while naming a particular disease. But, only name alone cannot provide you a treatment approach especially in *Ayurvedic* treatment. A proper Ayurvedic Nidan is nothing but to know proper *Doshawastha* irrespective of name of skin disorder. This paper will enlighten clinical fundamentals while treating a skin disorder with the help of case study. This case is elaborated with the help of *Trisutra Ayurved* i.e. *Hetu, Linga,Aushadh* 

## CASE REPORT:

A 15 year old female, school going girl from lower-middle class family comes at Sane guruji Hospital, Hadapsar with following complaints-

#### LING / LAKSHANAS: RUGNA SAMVEDYA LAKSHANAS: DURATION:

Started 8 years ago with gradual increase in lakshanas

- Nature of lesion Ubhay Hast Pada Tal Vranotpatti / Twachawidaran
- Raktaprawrutti+++,Pooyaprawrutti++
- Localised pain at *Hast,pada Tala* especially at wound site, resulting in difficulty while writing, walking etc.
- Generalised weakness, Angamarda

#### TREATMENT:

# NATURE OF LESION DURING COURSE OF DISEASE MANIFESTATION:

During initial days, it was occasional especially aggravates during Sharad, Hemant, Shishir rutu. Since 2-3 months patient started feeling pain at lesion site. Bleeding stared quiet often. And that was the time when patient starts thinking about treatment seriously.

## VAIDYA SAMVEDYA LAKSHANAS:

- All vitals were stable
- Thickened, redish, scaly, irregular lesion with bleeding and pus discharge
- Dryness / Khara Sparsh
- Itching especially at night or exposure to cold weather and cold intake.
- No proper treatment was taken since 8 years
- H/O-No history of any major illness.
- Agni–Visham
- Nidra-Samyak
- Malaprawrutti Asamyak, Irregular with timings
- Jivha Saaam

#### HETU:

Finding proper hetus (Causative factors) is actually a skilful job. This patient was a school going kid and all Hetus found are very typical and commonly seen in teenagers. During detailed case taking, Prakruti Parikshan and assessing Dinacharya of patient following Hetus were identified:

- Tamarind, Dadhi sewan, Achar/Chutney
- Biscuits, breade, chips, Chocolates
- Diwaswapna, wakeup late in morning
- Tea-chapatti -daily

#### **RESULTS:**

Ayurvedic treatment showed significant results. We can see clear result in pictures.

Patient had almost more than 80% relief in all symptoms within 3 months of period. Lesion get healed with improvements in other parameters like *Ahar*, *Nidra*, *Agni*, *Jivha* are also seen.



#### **DISCUSSION:**

All symptoms presented by patient were very chronic i.e. around 8 years. Yet, we get significant relief within 3 months is a very good achievement.

Rationals behind finding *Hetus and assessing Ling/Symptoms*: Such a quick relief is possible not only because of treatment alone but also Nidaan Parivarjan advised to this patient.

*Rakta Dushti* comes in the mind at first when we see any skin disease. But, one should not think of *Rakta Dushti Hetu* alone. Along with Rakta dushti one should think of Rasa Dushti Hetu because Rasa saarata is equal to Twak saarata also, Mamsa Dushti hetu because twacha is Upadhatu. So, one should remember these strong bonding or inter relation between these Dhatus.

One should rule out *Viruddha Aharaj bhaw* as it is another causative factor for Kushtha Vyadhi and Gara Visha. Gara visha cause Kushtha as they are inter-related.

Kushtha is described as a Tridoshaj Vyadhi. So approach is to find hetus of all these Doshas.

We can relate above mentioned *Sushrutokta* shloka in this patient as *Diwaswapna* is observed and we see gradual increase in symptoms over the period of time.

Hetusatatya over the long period of time causes recurrence and chronicity in the disease.

# Rational behind Treatment / useful fundamentals in treatment:

Patients with *Kushtha* approach various health care systems, try different medicine and such patients become more impatient, stressed about their skin diseases. The complete and prolonged clearance of the disease is the ultimate outcome and its achievable only with help of Ayurvedic management. In this case study, we can observe that, not only treatment but Nidaanparivarjan plays important role in treatment and Apunarbhav of disease.

Kushtha is Tridoshaj Vyaadhi. It shows Dhatugatawastha. We get specific Dushya Sangraha in our Ayurvedic text. Charakacharya explained Chikitsa Vishesh whike treating any skin disease. Hence, every time we have to assess Anshaansh Kalpana of vitiated Dosha with the help of Hetu and Ling.

- Sushrutatacharya explained importance of Sthan while treating a perticular disease. Twacha is predominantly Pittasthan. Hence, one should keep Sthan Dushti /Pitta Dushti always in consideration while treating Kushtha.

#### **CONCLUSION:**

Skin disorders show significant relief with help of Ayurvedic management. Name alone cannot provide you a treatment approach while treating *Kushtha*, especially in Ayurvedic treatment. A proper Ayurvedic *Nidan* is nothing but to know proper *Doshawastha* irrespective of name of skin disorder.
